# **Typical Inductance vs. Current Characteristics:**





# **Typical Temperature Rise vs. Current Characteristics:**








#### Soldering:

#### Cleaning and Washing:

### Potting:

If the product is potted in the costumer application, the potting material may shrink or expand during and after hardening. Shrinking

## **Storage Conditions:**

- The storage conditions stated in the original packaging apply to the storage time and not to the transportation time of the components.


## Packaging:
