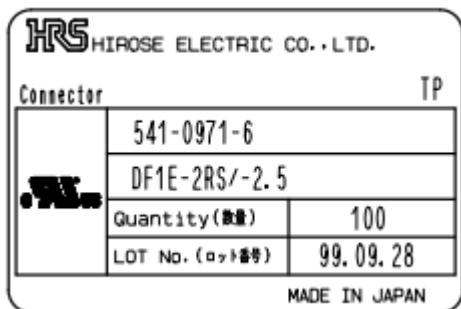

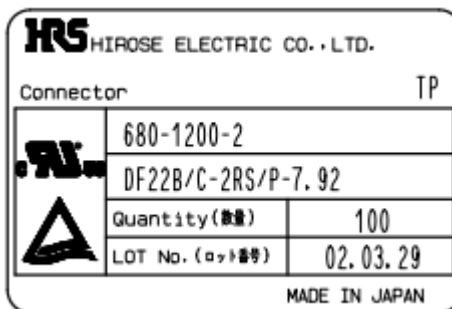
2. Changes

Figure 1. UL Label

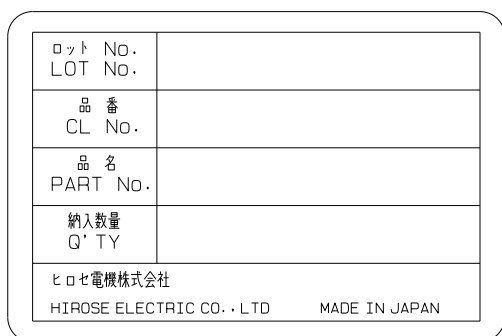


Figure 2. General-purpose labels
