According RoHS restrictions cadmium is only allowed to be used per an exception which is currently in discussion to be expired. In this situation first suppliers stop production of AgCdO contacts. To avoid short term decisions due to updated RoHS restrictions or due to supply problems of AgCdO we decided about regular discontinuance of the part numbers mentioned in this PCN. Well proved RoHS conform alternatives are available.
