### Product Discontinuance Details

Purpose, Description and Effect of Change:

This notification is to inform your company that Semtech is discontinuing the manufacture of the product listed below. In accordance with Semtech's product discontinuation policy, we are hereby giving notice of these product changes in order for your company to make any final lifetime purchases of the discontinued product that are still in supply.

Semtech is discontinuing this product due to its foundry partner, ASMC Shanghai, phasing out of their 5" manufacturing line. Semtech will not be transferring this product to another manufacturing line due to the high level of effort involved and declining volumes of the product.

Semtech proposes to support your future business by establishing a wafer bank. No later than 5/13/2019, you will provide Semtech with a projected forecast for up to 10 years of future demand for the devices below. You (or one of your agent's) will place a blank NCNR PO to cover the 10 year forecast quantity. Semtech will order, build and probe enough wafers to cover the above forecast, and place them in a wafer bank. Requested ship dates to be provided by you (or your agent) per the normal demand forecasting process. As firm ship dates are confirmed, wafers will be drawn from the bank and processed through assembly & test then shipped.

Support for all Quality and FA related items will be provided as normal. Semtech will hold current pricing throughout the wafer bank draw down.

Should you determine that no additional shipments are required, prior to consuming the full quantity of the blanket PO, Semtech will invoice you for the equivalent of the die level cost for the remaining product. The equivalent unit cost for the remaining product will be as follows:

### Limited Warranty

All discontinued product orders subject to this notice shall carry Semtech's standard limited warranty; or, if applicable, the warranty set forth in a duly executed formal contract between Semtech and your company will apply; except that:

1. Semtech will accept all valid warranty claims for credit only, unless a replacement order is otherwise agreed upon by Semtech and the replacement parts can be manufactured or delivered from remaining inventory.
2. The applicable warranty period for making any return claims for discontinued products will be no later than ninety (90) days following delivery of the discontinued products.
3. Any return claims must be made under Semtech's current Return Material Authorization "RMA" procedures.
